Disapplication of Pre-emption Rights

"That the Directors of the Company be and are hereby empowered pursuant to section 1022 and section 1023(3) of the Companies Act 2014 to allot equity securities (within the meaning of said section 1023) for cash pursuant to the authority conferred by Resolution 8 above as if section 1022 (1) of the said Act did not apply to any such allotment up to up to an aggregate nominal amount of EUR10,000,000, provided that this power shall expire on the conclusion

of the next annual general meeting of the Company unless and to the extent that such authority is renewed, revoked or extended prior to such date, save that the Company may before such expiry make an offer or arrangement which would or might require securities to be allotted after such expiry and the Directors may allot equity securities in pursuance of such an offer or agreement as if the power conferred by this resolution has not expired."
